I hope this finds you doing well and coping with the pandemic. This eNewsletter is intended to bring you up to date on some items, and on our income, expenses, and financial status so far this year.

Not including the deposits for Portugal trip, between what we received last year and what we have received so far this year, I find it very impressive that about 75 individuals, couples, and organizations have donated about \$60,000 in donations to the Buttrick Challenge. We have \$45,000 of that amount in a CD and the balance in our checking account. I am still hoping to reach the \$100,000 mark for donations to the Buttrick Challenge before 12/31/2020.

We expect to commence our annual membership renewal process shortly. When renewing, please consider making an additional donation to the Buttrick Challenge. All donations up to a total of \$100,000 will be matched dollar-for-dollar with all funds being placed in an endowment fund to earn interest and support student scholarships for years to come. All donations to the Buttrick Challenge are tax-deductible as provided by law. All donations must be received by 12/31/2020 to be eligible for the matching grant. It would be such a shame if we were not able to raise the \$100,000 in order to receive the full \$100,000 match.

You can quickly and easily donate to the Buttrick Challenge by visiting our website at vsaalumni.org and using PayPal. Just be sure to indicate Buttrick on the donation form. The form for donating by check is included in this eNewsletter.

As with just about everything else, the pandemic has thrown our plans for 2020 into the trash. Along with the VSA's postponements of their annual meeting in Denver, their study tour of Cleveland, and the three summer schools, the Alumni Assoc had to conduct our Annual Meeting in May by Zoom and postpone our tour of Portugal until March 2021. Many thanks to John Martine who has done a fantastic job juggling all of the pitfalls in planning the trip to Portugal in the midst of a pandemic. Acknowledgement letters for the tax-deductible portion of the trip price are in the works and will be sent by email asap.

Our General Fund includes donations to our named scholarship funds and membership renewals. We have a \$25,000 CD for some of that money with the balance of our funds of about \$30,000 in the checking account which includes about \$15,000 in Buttrick money which is not in the Buttrick CD as noted above. Since there were no Summer Schools in 2020 and thus no need for scholarships, the Alumni Board approved a donation of \$16,000 to the VSA Summer Schools to help with the fixed expenses incurred despite the cancellation of the schools. Our donation was very much appreciated by the VSA.

We sponsored recruitment events in NYC, SF, and Chicago. We paid for our membership software, and our minimal website and administrative expenses. We have continued to publish our eNewsletter periodically and received great reviews for our special editions on the Summer Schools. We continue to investigate the feasibility of updating and integrating the alumni website with the VSA website.

The VSA is planning for its national meeting in Denver in May 2021. At the meeting, the 2021 Preservation Awards and Book Awards are announced. Information on past recipients of these awards as well as instructions on nominations for the awards can be found here:

Of note, the terms of office for the current Alumni officers and board members expire on 12/31/2021. For those interested in serving on the Board, elections will be held at our May 2021 Annual meeting.

The tour showcases six of San Francisco's classic Victorian homes, private residences that can be visited **only** via this virtual event. This series of originally produced videos will introduce viewers to the homes' interiors, exteriors, furnishings and décor with new videos launching each week until October 23. Participants will meet the artisans and homeowners that have restored and cared for these homes, experiencing them through six different themes, including "Decorative Finishes", "Who Lived Here Before Me?", and "Future, Legacy".

After the initial launch, each video will be kept active and can be seen again, so that the end of the virtual house tour, all of the homes can be visited together. The Tour will culminate in a **Front Parlor Salon** webinar, scheduled for October 25, featuring leaders of preservation organizations from throughout the nation, sharing their ideas to inspire the next generation of passionate preservationists. Dr. Clark Strang Marlor (London 1982 and Newport 1988), age 97, died peacefully in the care of Tidewell Hospice, on July 16, 2020 in Sarasota, Florida. Born in Camden, New Jersey on November 18, 1922, he was the son of Alan Felten Marlor and Laura Strang Marlor. Clark received a BA degree from Carnegie-Mellon University in 1945, a MA degree from the University of Michigan in 1946, and a Doctor of Education degree from New York University in 1961.

Dr. Marlor was a Professor of Speech and Dramatics at Adelphi University from 1956-1986, and an emeritus professor since 1986. He is recognized as a noteworthy speech educator by Marquis Who's Who.

A longtime resident of Brooklyn, New York, Clark was an active life member of both the Brooklyn Historical Society (Board of Directors), and the Brooklyn Museum, where he volunteered for many years as a library archivist. Clark's enthusiasm for American art inspired him to research, document and write several books cataloging American artists and their exhibitions.

Clark also had a passion for his Victorian ancestry, which prompted him to become a life member of the Victorian Society of America, and a member and supporter of the Alumni Association. He enjoyed traveling with the Society throughout America and England to experience Victorian culture and architecture. He is fondly remember as a true Renaissance man and greatly missed by many of his friends in the Alumni Association.
