

# ALUMNI eNEWSLETTER

The Alumni Association held its Annual meeting as required by our bylaws on Zoom on May 5, 2021 in connection with the VSA Annual meeting. Many thanks to Kevin Rose and the VSA for hosting our meeting. Here are the draft notes from the Alumni meeting:



Correspondence Secretary **Jeanne Solensky** called the meeting to order and certified that a quorum was present. The Alumni members present at the meeting constitute a quorum per the bylaws.

Ms Solensky entertained a motion to dispense with the reading of the notes form the May 20, 2020 Alumni Annual meeting since those notes were distributed by email and US Postal Mail to all the current members of the Alumni Association. The motion passed unanimously.

Membership Secretary **Sara Durkacs** reported that the Alumni Association has 185 Households registered as dues-paying members which means about 234 individual members. Follow-up appeals continue, including our final "Pay-What-You-Can" to enroll lapsed members continues into 2021.

**John Martine**, Alumni Board member and Alumni Study Tour Director, reported that the VSA Alumni Study Tour to Lisbon, Portugal is still in a holding pattern. We have tentatively rescheduled it for March 2022 with 29 people. A survey of those who have signed up received mixed messages about traveling this year. So many unknowns

remain and difficult to predict what the situation will be several months in the future. Europe for the most part remains in lockdown with increasing cases of infection. A similar spike is happening in the US as well. Most respondents were concerned about our large group [29] being admitted as a group to restaurants and cultural sites such as museums, etc. Whether mask wearing will continue to be required, etc. Further information will be sent to the trip participants as soon as possible.

**James Russiello,** Alumni Association Director and Social Media Committee, reported that the social media accounts that the VSA and the Alumni Association are all now shared between the VSA and Alumni Association. Events of both organizations continue to be shared to increase the reach of the events notice. This has included the three event pages for the summer schools, and one recruitment event in NYC.

There were no live events for the Alumni Association to cover after February 2020. In past years, the VSA Alumni Association social media pages have been most engaged reporting on, and advertising live events. With the majority of these events canceled, there was less engagement with the Alumni Association pages than in past years.

Photo posts of a February alumni gathering in NYC received the most clicks and the VSA Summer School administrator posted virtual photo itineraries during the summer of what each of the three summer schools would have done on that day. The photos had been supplied by alumni from past years.

Photo posts receive more impressions and engagement than the link posts but in the absence of live events in the foreseeable future, the Alumni Association should focus more link posts. Most of the non-photo posts were created by David Lamdin, which typically advertised program events associated with other VSA individuals. These concise link posts helped maintain content on the FB page and in advertising the news and even of summer school alumni furthered the mission of the Alumni Association.

Recommendations for the FB page: Outside of direct emails and the website, Facebook remains the Alumni Associations most visible presence to non-active members. With David Lamdin's regularly emailed pdf newsletters, it might be advisable to share newsletter content via Facebook. Also, it would be good to have more moderators attached to the page to produce additional content.

**James Buttrick,** the Chair of the Alumni Finance Committee, reported that the Alumni Chapter raised \$217,008.50 for the scholarship Endowment Fund. The Finance Committee looked at several options for investing the money and chose eCIO [standing for "electronic Chief Investment Officer"] located in Madison, WI. They specialize in smaller non-profits, are cost-effective, and are easy to work with. An Investment Policy Statement has been drafted and approved by the Alumni Chapter Board. Funds have been transferred to the investment manager and will be gradually committed to the market over a six-month period to minimize the impact of market volatility. The portfolio will be broadly diversified.

**David Lamdin**, Acting Treasurer, reviewed the Income and Expenses of the Alumni Association in 2020, discussed the immensely successful Buttrick Challenge which ended on Dec. 31, 2020 and resulted in the Alumni establishing an Endowment Fund with a little over \$217,000. Excluding the Endowment Fund, the Alumni ended 2020 with a balance of \$48,394 in the main account. The additional funds in the Pittsburgh account are set aside for the Portugal trip and other Study Tour activities.

**David Lamdin**, the President of the Alumni Association, reported on the activities that the Alumni Association was involved in for 2020. Most of the energies of the Alumni focused on fund-raising for the Buttrick Challenge and membership maintenance. Every dollar donated for the establishment of an Endowment Fund was doubled. The special contributions of some 97 individuals, couples, and organizations to the Buttrick Challenge was a wonderful tribute to the faithful and generous support of our organization. The Endowment Fund will provide a strong foundation for the Alumni Association to continue its support of student scholarships for many years to come. A very special thanks to **Sue Verzella** and **Sara Durkacs** for their extra efforts and detailed care to keep track of the donations. And of course, our sincere appreciation to **Jim Buttrick** for his inspiration and very generous support.

The Alumni Board approved a budget for 2020 which included a donation of \$16,000 to the VSA to help with the fixed expenses of the schools which had to be canceled because of the world-wide pandemic. Before the cancelation of the 2020 schools, the Alumni Association supported recruitment events in San Francisco, Chicago, and NYC. The Alumni Association conducted a successful Annual Meeting via Zoom in May with the 2020 VSA Annual Meeting. With the cancellation of the 2021 Summer Schools and the funding by the Foundation for the great zoom lectures, no Alumni donations are contemplated for 2021.

The Alumni Association is deeply grateful to the VSA President **Kevin Rose**, for his detailed and comprehensive work on the new Alumni website. After the Alumni Association is able to decide on the few remaining issues including credit card options, the new website which will be incorporated into the VSA website will be ready to be tested fully and then go live. Many thanks to **John Martine** for his ongoing efforts in planning and rescheduling what is sure to be an amazing trip for Alumni. **Hannah Sigur**, our alumna in Lisbon has been working diligently organizing a great tour for us.

**Sara Durkacs**, the dedicated and very hard-working Membership Secretary of the Alumni Association, has completed processing all of the BC donations and is now focused on processing membership renewals.

Thanks to the chair of our Nominating Committee, **Travis Brock Kennedy**, and members **David Vespa** and **James Russiello** for their work. Many thanks to our current Board of Directors for their dedication, support, and guidance over the past three years, and thanks to those who will serve in that capacity from 1/1/2022 thru 12/31/2024.

A huge "thank you" to our Finance Committee (**James Buttrick**, **Sibyl Groff**, **Bob Chapman**, **and David Lamdin**) for the many hours lending their expertise to the establishment of the Alumni Endowment Fund and the Investment Policy statement. A special thanks to the members of the Alumni Association who faithfully support our mission to support the VSA in its educational mission and to provide scholarship funds for students attending the summer schools.

And finally, a very big "THANK YOU" to our Correspondence Secretary, **Jeanne Solensky**, for guiding us through the annual meeting.

**Travis Brock Kennedy**, the Chair of the Alumni Nominating Committee, reported that he and committee members **David Vespa** and **James Russiello** recommended the following individuals for election to the Board of Directors in the offices specified for the period January 1, 2022 through December 31, 2024

During the Alumni Association's October 2018 tour of Northern Ireland, we visited Clandeboye House, where we were met with most the gracious and enthusiastic hospitality of **The Marchioness of Dufferin and Ava**.





We were saddened to learn that the glamorous, charming, and artistic Marchioness of Dufferin and Ava recently died at the aged of 79. She was the daughter of MP Loel Guinness and his second wife, Lady Isabel Manners, swapping Belvoir Castle for Clandeboye Estate after her Westminster Abbey wedding to the Marquess of Dufferin and Ava. She was a talented artist - whose friends included David Hockney and Truman Capote - she will always be remembered for her pastoral scenes, many painted from her marital home in Northern Ireland, the Clandeboye Estate.



Born in 1941 at the height of the Second World War as Serena Belinda Rosemary Guinness, her birth was seen as an opportunity to boost wartime morale, with her father, Loel Guinness, of the brewing dynasty, encouraging his second wife Lady Isabel Manners to give birth at Prestick Airport, where his squadron was based.

As she later recalled: 'He said the birth should take place at the airport to cheer everyone up. New life in the middle of the war, you know.' After her parents divorced, she split her childhood between her mother's family seat, Belvoir Castle,

and Florida, where her father had moved with his third wife, the Mexican socialite Gloria Guinness. It was through her stepmother that she first met Truman Capote.

It was a chance meeting at a bonfire in 1958 with Duncan Grant of Bloomsbury Group fame that led to her realization that art was her calling. She went on to be one of Grant's pupils at Charleston, before going on to further study at Byam School of Art, Chelsea School of Art and the Slade. In 1964 she married her fourth cousin, Sheridan Dufferin, the 5th Marquess of Dufferin and Ava, who shared her interest in the arts and was a great patron of them himself.



The couple were wed at Westminster Abbey, in a glamorous ceremony that saw 2,000 guests, including Princess Margaret and Lord Snowdon. She wore a very sophisticated ivory gown by John Cavanagh, accessorizing with the Dufferin and Ava shamrock tiara, a diamond and pearl diadem dating back to the 1800s.

The couple were joined on their honeymoon by David Hockney - whose talent Sheridan had spotted early - before returning home to Holland Park in London, where they became major movers and shakers on the art and party scene. They also spent some time returning Clandeboye, Sheridan's family seat in Northern Ireland, back to its former glory, hosting parties for the likes of Prince Charles.

After her first show in 1971 at the Harvane Gallery, Lady Dufferin went on to have shows in Paris, Belfast and Dublin, and despite mastering a wide range of styles, was most fond of painting her herd of pedigree cows. After her husband's death in 1988 from AIDs related illness, she inherited Clandeboye, planting a memorial garden in his honor and opening a gallery, not to mention building up her herd of cows, who appeared on dairy products sold by the house. She even installed an 'honesty shop' in which customers could pay for items they took, with no staff (it was once victim to thieves at Christmas, but she played down their malice by claiming that they must not have been feeling very 'Christmassy' that year).



She was still painting earlier this year, and during lockdown produced some wonderful landscapes, with plans for an exhibition. The cause of her death is not known. In a public message from Clandeboye Courtyard, where she often popped over to see newlyweds arrive for their wedding breakfasts, a spokesperson said:



"We regret to announce the death of Lindy, Marchioness of Dufferin and Ava, after a short illness. She was a friend to so many and was beloved by all. Painting and Clandeboye were her twin passions and we can take some solace that her last months with us allowed her to indulge both and brought her peace and happiness doing the things she enjoyed most. She had a fantastically full life. Given current Covid restrictions there will be a private funeral at Clandeboye in accordance with her wishes but there will follow memorials in celebration of her life at both Clandeboye and London."
