The Alumni Association extends best wishes for the holiday season and best wishes for a healthy and happy new year!

The Alumni Association's annual membership renewal season is underway. Many thanks to all those who have already renewed! Your faithful, consistent, and significant support is sincerely appreciated. Your membership and donations will enable the Alumni Association to continue its support of VSA Summer Schools students with scholarship money. With the schools starting up again in 2022, the Alumni Association hopes to provide significant scholarship support to students in 2022.

Just click on the "donate" button and follow the instructions to pay with your credit card or PayPal account. If you encounter any problems, please try a different browser.

Cognizant of the difficulties encountered in our country stemming from the pandemic, the Alumni Board has authorized **a special one-time reduced membership rate of \$25** for 2022 to encourage all to renew their memberships. Please take advantage of this special rate or renew at the current rate beginning at \$55 for an individual.

The source of the Alumni Association funds includes the annual membership fee (which is a separate membership fee from the VSA), and largely from generous alumni who donate at the Supporter and above membership level, to the special scholarship funds, and to honorary and memorial donations. Alumni Association membership benefits include: opportunities to participate in the Alumni Association's national and international Study Tour Programs that include exclusive access to historic sites, private homes, and private collections; invitations to special events nationwide; an invitation to attend the Alumni Association's Annual Meeting & Dinner often held in a private home in connection with a VSA Study Tour; and publications keeping members informed of activities - only current Alumni Members may submit essays for possible publication and join the Alumni Association Study Tour.

As you consider your yearend giving options and as a further incentive to donate to the charity of your choice, and while you should contact your tax advisor for information on any issues with your taxes, the Alumni Association notes that certain provisions of the CARES Act, which went into effect in 2020 have been extended for 2021 donations.

Ordinarily, individuals who elect to take the standard deduction cannot claim a deduction for their charitable contributions. The law now permits these individuals to claim a limited deduction on their 2021 federal income tax returns for cash contributions made to certain qualifying charitable organizations including the Alumni Association. Nearly nine in 10 taxpayers now take the standard deduction and could potentially qualify to claim a limited deduction for cash contributions. These individuals, including married individuals filing separate returns, can claim a deduction of up to \$300 for cash contributions made to qualifying charities during 2021. The maximum deduction is increased to \$600 for married individuals filing joint returns.

As a chapter of the VSA, the Alumni Association is a non-profit 501(c)(3) tax-exempt organization. Contributions are deductible as provided by law. Your faithful support of the Alumni Association and its primary mission to raise funds for student scholarships is greatly appreciated. For the summer schools in 2017, 2018, and 2019, the Alumni Association was able to provide about \$72,500 in scholarships to some 31 Summer Schools students who otherwise might not have been able to attend. In 2020, the Alumni Board also authorized a donation of \$16,000 to help the Summer Schools cover some of their fixed costs while the schools were shut down because of the pandemic.

The Alumni Association recently learned of the passing of Susan (Susie) Wagg (London, 1981). Susie was a long-time member of the Alumni Association. Susie died at her home in Hanover, New Hampshire, on November 28, 2020. Susie was born in St. Louis, Missouri, on June 26, 1938. She attended Wellesley College and majored in History of Art. After graduating in 1960, she married Timothy Wagg of London, England. They moved to Montreal, Quebec, in 1961, following his graduation from Harvard Business School.

In her early years in Montreal, Susie briefly ran the Museum of Fine Arts program for the Protestant School Board. She then

stayed home for a number of years to raise their two children, Sandra and Geoffrey. When they were in elementary school, Susie obtained a Master of Fine Arts from Concordia University in Montreal, specializing in Canadian architectural history.

Susie's love of architecture and architectural history led her and her family on many architectural pilgrimages. She traveled throughout Canada, the United States, and Europe. She had a particular interest in Canadian architecture and used her gifts for research and writing to bring appreciation and recognition to several notable Canadian architects. She wrote four books and co-authored several other books and articles on architects. Susie was elected to the Royal Society of Arts in 1987 for her work in bringing recognition to Canadian architects and architecture.
