Cognizant of the difficulties encountered in our country stemming from the pandemic, the Alumni Board has authorized **a special one-time reduced membership rate of \$25** for 2022 to encourage all to renew their memberships. Please take advantage of this special rate or renew at the current rate beginning at \$55 for an individual.

The source of the Alumni Association funds includes the annual membership fee (which is a separate membership fee from the VSA), and largely from generous alumni who donate at the Supporter and above membership level, to the special scholarship funds, and to honorary and memorial donations.

Alumni Association membership benefits include: opportunities to participate in the Alumni Association's national and international **Study Tour Programs** that include exclusive access to historic sites, private homes, and private collections; invitations to special events nationwide; an invitation to attend the Alumni Association's Annual Meeting & Dinner often held in a private home in connection with a VSA Study Tour; and publications keeping members informed of activities - only current Alumni Members may submit essays for possible publication and join the Alumni Association Study Tour.

For the summer schools in 2017, 2018, and 2019, the Alumni Association was able to provide about \$72,500 in scholarships to some 31 Summer Schools students who otherwise might not have been able to attend. In 2020, the Alumni Board also authorized a donation of \$16,000 to help the Summer Schools cover some of their fixed costs while the schools were shut down because of the pandemic.
