""Necessitous Men Are Not Free Men': The Influence of Ruskin and Settlement Houses on the New Deal" by Gray Brechin. Pres. Franklin Roosevelt's New Deal programs were not just an unprecedented effort to extricate the U.S. from the Great Depression but a concerted effort to use government to create healthier individuals and society in the process. Many of the leading New Dealers including Frances Perkins, Harry Hopkins, and Eleanor Roosevelt had worked in settlement

houses earlier in the 20th century which were themselves inspired by the moral suasion of John Ruskin. Settlement houses were closely connected to the Arts & Crafts Movement as seen in the Mary Ward House in London's Bloomsbury neighborhood.

VSA Alumni Association Report of 2021 Activities

The Alumni Assoc held a successful Annual Meeting via Zoom on May 5, 2021. At that meeting, a new Board of Directors was elected for the period 2022 through 2024. As of 12/31/2021 there were 148 Household members.

The Study Tour to Portugal was again postponed until 2022.

The Buttrick Challenge was very successfully completed. With the donations of over \$100,000 and the \$100,000 match, together with the transfer of funds from the general revenue account and accumulated interest, a total of \$217,008.50 was raised for the Scholarship Endowment Fund. Every dollar donated for the establishment of an Endowment Fund was doubled. The special contributions of some 97 individuals, couples, and organizations to the Buttrick Challenge was a wonderful tribute to the faithful and generous support of our organization.

The Alumni Board selected a brokerage to manage the account in accord with the Investment Policy Statement approved by the Alumni Board.

There were no Summer School Recruitment Events in 2021 and there were no Alumni funds spent on scholarships in 2021.

The Alumni Association published 10 eNewsletters in 2021.

Many members of the Alumni Association participated in, supported, and thoroughly enjoyed the excellent video lectures presented by the VSA in 2021.
