# Alumni Association Annual Dinner

Pre-pandemic, the Alumni Association held its Annual Meeting in connection with VSA Study Tours. The Alumni either held its meeting with the VSA annual meeting or we held it during our Annual Dinner. Since the pandemic, the Alumni Association has held its last two Annual Meetings as part of the VSA Annual Meeting on Zoom. In view of the increased attendance and other factors, the VSA has decided to continue to hold its Annual Meetings on Zoom in November of the year. For 2022, the Alumni Board recently decided to continue to join the VSA Annual Meeting via Zoom in November. Further details will be provided as the November date draws near.

The VSA will be sponsoring a Study Tour to Denver in May 2022. The Alumni Board has decided to continue the Annual Alumni Dinner as a community building event in connection with the VSA Denver Study Tour because the tour will attract the largest alumni gathering. The dinner will be held on Friday May 20 from 7:00 pm to 9:00pm at the University Club of Denver located just two blocks from the tour headquarters hotel.

The VSA has requested that all reservation for the tour and hotel be made by April 1. Accordingly, advance reservations for the Alumni Dinner will also be due by April 1. Depending on the number of people who reserve for the Alumni Dinner by April 1, we will either get a private room at the Club with a preselected platted dinner or make reservations at the club member dining room. If we engage the private dining room, once we give a final number of people to the club, we have to pay for those dinners whether people show up or not.

A sample menu would include a University Salad with heritage greens, crumbled goat cheese, dried cranberries, and candied walnuts; a main course choice of a 6 oz bistro tenderloin with green peppercorn demi-glace or a Pan-seared Norwegian salmon with ratatouille ragout (both come with a ruby red and wild rice pilaf and the chef's mixed vegetable medley); and NY cheesecake with seasonal fruit compote.

The cost will be about \$85 per person including tax and tips in the private room. Cost will vary if we go to the member dining room depending on entre selection and drinks ordered. Shortly after April 1, we will determine the number of people who want to attend the Alumni Dinner and the appropriate venue. # **UPDATES from the Summer Schools**

After weighing the pros and cons posed by covid, it was decided to proceed with all three Summer Schools this year. 2022 will be Jo Banham's final year as the London School Director although she plans on remaining active with the program as an occasional lecturer. 2022 will also be Liz Leckie's final year as Assistant Director which means that beginning with the 2023 program there will be new leadership.

Kit Wedd, a former co-director of the London School, has enthusiastically agreed to be the next London Director starting next year. Kit is the Director of Spurstone Heritage, a London-based consulting firm that provides advice on conservation and development of historic sites and buildings.

Leslie Klingner, a member of the VSA Sumer School Committee who has been the Curator of Interpretation at Biltmore Estate for many years, has agreed to be the next Assistant Director of the program starting in 2023.


# Report on VSA Online Lectures Series, Season 2

Following the postponement of the three VSA Summer Schools and Study Tours in 2020 and 2021, it was decided to inaugurate a series of online lectures, sponsored by a grant from the Victorian Society Scholarship Fund. The first season, which ran from February through August 2021 saw an average attendance of just over 200 people for each of the twelve free lectures, from all over the United States and abroad. The

content of the three summer school programs was the inspiration for the subject matter addressed within the series, and a number of lecturers either lectured for one of the summer schools or served as director.

The series of 19 lectures launched in September 2021, were once again administered and moderated by Summer Schools Administrator Anne Mallek. They variously addressed the themes of "Great 19<sup>th</sup>-Century Styles," "Modern Masters," "Craft and Conservation," "Women Artists, Designers, Architects," and "Artists and Architects at Home." To date, there has been an average attendance of just over 100 for the lectures in this second series, and an average registration of 244. Although the number of live attendees is frequently half that of the number of registrants for any given lecture (this was also true of the last series), this is generally made up in the number of recording views (averaging 146 per lecture).

The VSA has also seen an increase in memberships and donations over the past year, likely due in large part to the lecture series.

""Necessitous Men Are Not Free Men': The Influence of Ruskin and Settlement Houses on the New Deal" by Gray Brechin. Pres. Franklin Roosevelt's New Deal programs were not just an unprecedented effort to extricate the U.S. from the Great Depression but a concerted effort to use government to create healthier individuals and society in the process. Many of the leading New Dealers including Frances Perkins, Harry Hopkins, and Eleanor Roosevelt had worked in settlement houses earlier in the 20th century which were themselves inspired by the moral suasion of John Ruskin. Settlement houses were closely connected to the Arts & Crafts Movement

as seen in the Mary Ward House in London's Bloomsbury neighborhood.
